

Minutes of Annual Meeting held on 7th June, 2019

Ms. Anne Maria Walsh, Meetings Administrator, opened the meeting. She welcomed all the members to the first meeting of the new term of office for members elected to Kilkenny County Council.

Before commencing with the formal business Cllr. E. Aylward addressed the meeting.

Outgoing Chairman's Address:-

"Firstly I want to congratulate all of you on your election to this chamber. Well done to those you who have been re-elected but I particularly want to welcome the newly elected members to your 1st official meeting and I am looking forward to working with you all over the next five years.

It has been a huge honour for me to serve as Cathaoirleach, when I sat here a year ago June 2019 seemed an awful long time away but looking back now it has just flown by. It has been an extremely busy year but a huge enjoyable year in the role you realise how popular Kilkenny is for both National & International conferences which is testament to the high esteem Kilkenny is held in and is a place people want to come to.

This council has made huge progress in the last year with a number of large projects progressing such as the Piltown Bypass Flyover, Kilkenny Greenway, Western Environs and the Abbey Quarter, we have to keep moving forward as a Council and everyone here wants the best for County Kilkenny.

As my terms comes to an end I want to say a few thank you's.

Firstly, I want to thank you the members and especially my Fianna Fail colleagues for giving me this honour last year and for your co-operation in ensuring that our meetings progressed smoothly most of the time.

Thanks to Andrew McGuinness, Leas Cathaoirleach, who willingly carried out the role of Cathaoirleach when I was unable to attend events.

Thanks to Colette, Mary, Tim, Sean & Martin and all the staff in the council for your help and support over the year, but in particular want to thank Teresa, Brenda, the two Catherine's, Siobhan and this lady to my left, Anne Maria, for keeping me organised and in the right place over the year.

I want to thank my employers Campion Insurance for facilitating me to carry out the role of Cathaoirleach, it's not easy to keep the two jobs going but there was never an issue with getting time off which isn't the case with every employer.

I want to thank my wife, Lorraine. and my three boys for their support over the year, its not easy on the home life and it is especially hard in an election year and we also have Leaving & Junior Cert in the house at the moment.

Finally, I want to wish the incoming Cathaoirleach the best for the coming year, it's the highest honour in Kilkenny, something that needs to be remembered that the Cathaoirleach is the 1st Citizen of Kilkenny."

Item 1. Election of Cathaoirleach

Cllr. Peter 'Chap' Cleere was proposed as Cathaoirleach of Kilkenny County Council for the ensuing year by Cllr. A. McGuinness and seconded by Cllr. M.H. Cavanagh. There were no other proposals. Accordingly, Cllr. Peter 'Chap' Cleere was unanimously elected as the Cathaoirleach of Kilkenny County Council for the coming year.

The incoming Cathaoirleach thanked his proposer and seconder and addressed the meeting as follows:-

“I want to thank everyone for giving me this opportunity to be the Cathaoirleach of Kilkenny County Council. It is a tremendous honour for me and my family and I look forward to being a fair and consistent Chair for the coming 12 months.

Kilkenny is an amazing County, where we value our heritage, our history and our culture but also celebrate its diversity. There are so many brilliant ambassadors in every community right across the County and it is their sense of pride and passion in their areas that make Kilkenny so special. Ordinary people doing extraordinary things.

Over the next 12 months and indeed over the next five years, Kilkenny has very ambitious plans for growth, and I am very excited to play a key role in this journey.

The development of the Abbey Quarter will ensure that this vibrant City will continue to grow and has the potential to make Kilkenny a serious player in terms of attracting national and international business and which will provide employment opportunities for our children and indeed our children’s children. I am encouraged to see plans for the new County Library develop and excited to see this project progress over the next 12 months. A community without a library is a community without a soul and this new state of the art facility will be of huge benefit to everyone in Kilkenny City and County.

I am also looking forward to overseeing the completion of the LIHAF Scheme, which will ensure the infrastructure is now in place for the development of a significant number of houses over the next number of years. In addition, and in my role over the next five years as Chairman of Kilkenny Carlow ETB, I now look forward to seeing work commence on two new secondary schools, which will provide the best of learning facilities in an environment which will allow these students achieve their ambitions. The new Kilkenny School Gael Choláiste for those who wish to study through the medium of Irish will ensure our children will have state of the art facilities and enable them to achieve their dreams.

Staying on the topic of education, I believe it is absolutely imperative that we secure a 3rd level campus for Kilkenny on the Abbey Quarter site. We need to ensure that we get a facility which will lead to a skilled workforce and I am looking forward to playing my part as Chairman in securing this facility for Kilkenny.

It was with great delight that Kilkenny County Council received €31m in funding last year for flood relief programmes in six towns around the County. I am looking forward to working with newly appointed engineers and the design teams that will be appointed at the end of this month. It is important that we have full public participation and consultation to ensure these projects will be delivered over the next couple of years in Graiguenamanagh, Thomastown, Ballyhale, Inistioge, Freshford and Piltown.

I am also looking forward to continued success in our Rural Regeneration application and Town and Village Scheme applications. Thomastown and Callan were successful in the latest round, both Graiguenamanagh and Piltown had excellent applications and should be successful next time around.

It is my intention to continue to seek funding for our local road network. We are very fortunate in Kilkenny to have excellent roads, particularly in comparison to other counties, but it is important not to get complacent and I will be lobbying hard for additional funding for Kilkenny.

Evans Home is a project which will be completed this year and will host the Butler Gallery. A significant investment in our Arts, and one that I look forward to seeing open in my term as Cathaoirleach.

To conclude, I want to thank you, the Members, for your support today. I want to also pay tribute to the local media who have consistently attended all our Municipal and County Meetings, thank you. I want to say I look forward to working with the Executive over the next 12 months. And finally, I want to thank my family and supporters who have given me the encouragement, support, advice and the inspiration to enable me fulfill my dreams. In particular, thank you Brenda, Gracie, Emily, Holly and Hannah. Thanks for believing in me."

Report on Local Elections was circulated with the agenda for the member's information.

The Report was proposed by Cllr. P. Fitzpatrick and seconded by Cllr. M.H. Cavanagh as being noted and taken as read.

Item 32. Standing Orders Kilkenny County Council – Review.

Cllr. A. McGuinness proposed an amendment to Standing Order No. 62 as follows:

“Corporate Policy Group

The Cathaoirleach of the Council, the Chairpersons of each Strategic Policy Committee, the Parties Whips and a nominated Member from the Municipal Districts if the Municipal District is not represented shall form the Corporate Policy Group, which shall meet as often as required under the chairmanship of the Cathaoirleach and shall provide a forum for discussion of policy affecting the whole Council and shall report to Council in accordance with Section 133 of the Act of 2001 as amended by Section 48 of the 2014 Act.”

This was seconded by Cllr. M.H. Cavanagh and agreed by all.

Cllr. M. Noonan proposed an amendment to Standing Order No. 60 that the Media and Public be allowed to attend SPC Meetings. This was seconded by Cllr. T. Breathnach.

Contributions were received from Cllr. M. Noonan, Cllr. P. O'Neill and Cllr. M.H. Cavanagh in relation to the attendance of public and media at meetings, where policies are formulated and discussed.

Mr. T. Butler advised that the SPC are Statutory Committees set up to discuss and develop/formulate/review policies. All draft policies such as Development Plans, Bye Laws are advertised for public submissions. The final draft Policies or Bye Laws come before the Plenary Council for approval. The SPCs are made up of Elected Members and External Members working with social, economic, culture and environmental bodies. The external member provides the committees with external views as policies are developed. Attendance by the Press and Media might inhibit the members from making views known. The public have an opportunity to make submissions where policies or plans are put out for public consultation.

Some members expressed concerns that these meetings are intended to enable draft documents to be formulated and discussed and attendance by public and media may prevent open discussion by the members of the SPC and relevant staff.

Cllr. M.H. Cavanagh proposed an amendment that Standing Order No. 60 remain as circulated. This was seconded by Cllr. A. McGuinness. Cllr. P. Cleere advised that he was calling on a vote by a show of hands on amendment that Standing Order No. 60 remain unchanged:
