### 2. Description of Proposed Development


The proposal put forward on public display is for works to

The Latrine, Butler Gallery, Evans' Home, Johns Quay, Kilkenny.


Development consists of:-






Existing Floor Plan




Proposed Floor & Roof Plan

# 7. Implications for Proper Planning and Sustainable Development of the Area

Re: Planning report on alterations to former Latrine within the curtilage of protected structure Evans Alms House (ref. B3). Works to include new structure inserted within the existing walls and all related site development works and ancillary works at The Latrine, Butler Gallery, Evans Home, Johns Quay, Kilkenny.

Part VIII Proposal

Under this Part VIII proposal, Kilkenny County Council is proposing to alter the former Latrine building located within the curtilage of Evans Alms House. The alterations consist of a new structure, namely a concrete raft foundation, inserted within the building so as to create a new timber pod structure.

A structural report is included with this proposal which concludes that the existing external walls are being retained and only minor repairs are needed to the masonry. Two walls are to be removed and these are to be replaced with steel stanchions in order to provide sufficient lateral stability under wind loading.

A Design Statement from Canice Architects is also submitted which outlines the scope of the works and the proposed design and visual impact.

An Architectural Heritage Impact Assessment is carried out in relation to this proposal, dated November 2020 and carried out by Canice Architects and this concluded that the works proposed constitute a light touch intervention on the existing building and that all works will be carried out in accordance with Architectural Heritage Protection – Guidelines for Planning Authorities and Best Conservation Principles.

A report dated September 2016 is also included with this proposal and this is titled Combined Reports on Archaeological Excavation Work at Evan's Home, John Street, Kilkenny.

A report dated February, 2011 by Claire Walsh is also included with this proposal titled Archaeological Test Excavation at Back Lane, Kilkenny as is a further report dated June 2012 by Claire Walsh on Archaeological Monitoring of Greenhouse and Treeroot Removal at Evans Home, John St., Kilkenny.

Zoning

The site falls within a zoning of 'General Business, within the Kilkenny City and Environs

Development Plan 2014 - 2020, with an objective to provide for general business.

### Heritage

Protected Structure - B3 - Evans Alms House, NIAH reference 12000216.

Recorded Monument - None on site. Evans Alms House adjoins St.John's Church and graveyard, both recorded monuments, reference RMP KK019-026115 & KK019-026156.

ACA - The site falls within the Johns Street Architectural Conservation Area.

SAC - The site is a good distance from the River Nore cSAC...

SPA - The River Nore SPA is a good distance to the south of this site.

pNHA – The site is not within any pNHA.

Zone of Archaeological Potential - The site is located within the Zone of Archaeological Potential for Kilkenny City, established under the National Monuments Act.

### Relevant Planning Policy and Guidelines

Kilkenny City and Environs Development Plan 2014 - 2020

### Planning History

No planning applications relevant to this site.

There is a Part 8 applicable to this site for the conversion of Evans Home to the Butler Gallery.

#### **EIA Conclusion**

A preliminary examination of the nature, size and location of the proposed development has been carried out which determines that there is no real likelihood of significant effects on the environment arising from the proposed development. It is therefore concluded that an EIAR is not required.

### **AA Screening Report**

An Appropriate Assessment Screening Report was carried out on this application and this concluded that this development would have no impact on the River Nore SAC, thus a Stage 2 NIS was not required.

### Pre-Planning

Pre planning discussions were held in relation to this proposal and advice provided on this proposal.

### **Third Party Submissions**

This Part VIII proposal was placed on public display from Friday 15<sup>th</sup> January, 2021 to Friday 12<sup>th</sup> February, 2021 and no submissions were received during this timeframe.

### **Internal and External Departmental Submissions**

Conservation Officer - No objection to the proposed works.

Department of Arts, Heritage, Regional Rural and Gaeltacht affairs – Request archaeological monitoring of works.

#### Assessment

Under this Part VIII, it is proposed to alter the former Latrine building located within the curtilage of Evans Alms House (Butler Gallery). The alterations involve a new structure inserted within the building which is a concrete raft foundation and will contain a new timber pod structure.

Due to the building located within the grounds of a protected structure and on the National Inventory of Architectural Heritage, an Architectural Heritage Impact Assessment was carried out on this proposed development which concluded that the works proposed constitute a light touch intervention on the existing building and that all works will be carried out in accordance with Architectural Heritage Protection – Guidelines for Planning Authorities and Best Conservation Principles. The works will also be supervised by a Conservation Architect.

The works do not impact on the nearby protected structure, Evans Alms House, nor will they impact on the nearby St.John's Church and graveyard, both recorded monuments. Also with the structure being in the curtilage of Evans Home, there will be no visual impact on the John Street Architectural Conservation Area within which this site is located. Finally, with the works being internal in the Latrines building, this will ensure that the proposal will not detract in any way from its surroundings, visually, architecturally or archaeologically.

### Recommendation

The Planning Authority recommends that this Part 8 application be approved by the Council.

The works shall be archaeologically monitored as per the request of the Department of Culture, Heritage and the Gaeltacht in their report submitted to the Planning Authority on 25<sup>th</sup> February, 2021.

The recommendations contained within Section 6.0 of the Architectural Heritage Impact Assessment shall also be adhered to throughout this development.
