3. Review of Roadworks Scheme for Municipal District

Mr. Kieran Fitzgerald circulated a report to the Members on the Roadworks Scheme for for Kilkenny City and Environs and gave a brief presentation in relation to same. The Members thanked Mr. Fitzgerald and raised queries in relation to the following:

- Signage at Dunningstown Lane/Road.
- Provision of additional bus shelters in 2015.
- Works at Kennyswell Road and Fr. Walshe Close.
- Medieval Mile next phase.
- Safety measures at Greensbridge.

Mr. Fitzgerald responded to all queries raised.

Mr. Seamus Foley circulated a report to the Members on the Roadworks Scheme for the Callan Area. Members thanked Mr. Foley and his team for the works carried out during the year. Mr. Foley responded to a number of queries raised by Members in relation to the Scheme.

Mr. Tony Lauhoff circulated a report to the Members on the Roadworks Scheme for the Thomastown Area. Members again complimented Mr. Lauhoff and his team on the works carried out during the year and Mr. Lauhoff responded to queries raised in relation to:

- Low cost Accident Scheme.
- Works at Graiguenamanagh and Gowran.
- Maintenance of school warning signs.
- Lighting of bridge in Bennettsbridge.
- Playground at Thomastown.
- Provision of speed ramps.

During a discussion on the roadworks schemes for the Municipal District it was proposed by Cllr. Matt Doran and seconded by Cllr. 7. Presentation on Medieval Mile – Marketing and Branding/Identity.

Mr. Brian Tyrrell gave a presentation to the meeting on the promotion of the Medieval Mile Brand in Kilkenny and the benefits that the promotion of the brand can provide to the business community in Kilkenny. Following the presentation the Members thanked Mr. Tyrrell for his presentation and Mr. Tyrrell responded to a number of queries raised.

"That Kilkenny Municipal District Council would develop

- 1. a five year workplan for the conservation and restoration of the funerary monuments
- 2. a landscape/biodiversity enhancement plan in St Mary's Church and Graveyard.

Such work plans would include exploring possible sources of co funding to complete works, an annual schedule of works, archaeological investigation and recording, community participation and conservation skills training in line with recommendations made in the 2005 Heritage Council Conservation Plan for St Mary's Church and Graveyard.

The 2005 Heritage Council Conservation Plan for St Mary's Church and Graveyard was developed by the Heritage Council with the support of a stakeholder forum. While the plan deals with issues of conservation of the Church Hall, it places significant focus on the International significance of the funerary monuments. Extensive reports and on site investigation since the plan was written can adequately inform a draft work plan".
