4. Review of Kilkenny County Council's Programme of Speed Limits

Mr. Declan Murphy, A/Executive Engineer, outlined the principle requirements determining the speed limits and gave a Powerpoint Presentation in respect of same. Mr. Murphy explained that the Members' approval is sought to put the proposed programme on public display in June, 2016.

5. Notice of Motion in the name of Cllr. Peter 'Chap' Cleere received 4th April, 2016:

Proposed by: Cllr. Peter 'Chap' Cleere Seconded by: Cllr. Andrew McGuinness

"That this Municipal District would seek immediate funding from the department of transport to ensure that all local roads in Kilkenny -Local Primary (LP), Local Secondary (LS) and Local Tertiary (LT) have adequate and sufficient numbering. The Roads Act 1993 gives local authorities the duty to "assign a number or other identifying mark to each local road in respect of which it has responsibility."

6. Notice of Motion in the name of Cllr. Malcolm Noonan received 8th April, 2016:

Proposed by: Cllr. Malcolm Noonan

"That Kilkenny Municipal District Council would initiate a process to re-design and revitalise the Parade and Gravel (Mayor's) Walk. This would include seating accommodation of an inter-generational amenity area, accommodation of a performance area for concerts and accommodation of further cycle and motorcycle parking".

Cllr. Noonan clarified that he was not seeking a redesign of the Parade, but rather the use of the area, particularly the gravel walk, referencing the surface condition and the placement of intergenerational amenities, to promote active uses.

Mr. Seamus Kavanagh, Senior Engineer agreed to review the area and revert to members with a report.
