3. Leithdháilte Ghinearálta Municipal 2018 General Municipal Allocation – Funding Allocation.

Members agreed to defer this item for listing on the Agenda for the monthly meeting in January, 2018.

4. Clár Comórtha Náisiúnta 2018 go 2023. National Commemorative Programme 2018 to 2023.

Ms. Mary Mulholland advised that the Government have launched a national public consultation process to determine how the State will recall significant historical events that took place between 1918 and 1923 which will run up to 31st January, 2018. The objective of the commemorative programme is to promote a deeper understanding of differing perspectives on this sensitive period in our shared history.

In response to suggestion made Ms. Mulholland agreed to include the following in the submission:

- Involvement of Libraries and PPN.
- Make available venues in the City and County for road show or touring format.
- Support of research projects such as Kilkenny Archive, Hurling Museum, James Stephens Barracks and Iverk Show.

- Favour a multi-annual funding mechanism, regionally available expertise in research and archival requirements and a dedicated resource to co-ordinate events and projects through assessment, development and delivery.
- Clear point of contact in each local authority or shared between local authorities is desirable.

This request comes in light of the National Climate Change Advisory Council recommendation that there should be a move from investment in conventional diesel vehicles for public transport. This motion recognises Kilkenny's commitment to meeting targets locally under the Covenant of Mayors Sustainable Energy Action Plan and that this Council has a desire that Kilkenny would have the first full electric or biogas bus fleet in Ireland."
