Stoneyford Village Renewal Scheme

Cllr. Matt Doran requested an update on plan of works going forward for the Stoneyford Village Renewal Scheme. In response, Mr. Tim Butler advised that if there is no funding available nationally to carry out any further works, the Council will have to provide funding from the Road Works Scheme.

Health and Safety Issues at Road into Hebron Industrial Estate

Mr. Seamus Kavanagh agreed to get a cost on the provision of CCTV as requested in the Motion and in the short term agreed to carry out the following:

- Put remote cameras in place over the next few weeks.
- Additional signage will be erected.
- Litter Warden to examine bags of refuse.
- Leaflet drop to be carried out in the area.

"That Kilkenny Municipal District Council would engage the Environment Officer of Kilkenny County Council to assess the scale of illegal fly tipping of waste in Kilkenny City by (a) carrying out a door to door survey of all City Centre dwellings to establish proof that the household is disposing of waste and recyclables with an authorized contractor, availing of the city domestic scavenging service or disposing of waste and recyclables in an authorized facility (b) erecting surveillance cameras at key points in the City where illegal dumping is a problem (c) producing an information leaflet on responsibilities in relation to the Waste Management and Litter Act in a number of languages and (d) engaging the Environment and Planning Strategic Policy Committees to start a process of reviewing the planning requirements for storage and presentation of waste and recyclables in urban areas. The objective of these measures is to take a proactive approach to the changes in waste management policies and planning requirements for apartments and urban centre living."

It was agreed to invite a representative from the Environment Department of Kilkenny Council to make a presentation at the March Meeting in relation to the points raised in the Notice of Motion.
