Following a discussion on Tidy Towns Groups in Kilkenny, it was agreed to request a representative from the Environment Department to attend the next Municipal District Meeting for a review of Tidy Towns in the Municipal District.

3. Cur i láthair ag SIRO SIRO Presentation.

Representatives from SIRO gave a presentation on SIRO's 100% fibre broadband which is a joint venture between ESB and Vodafone and is being rolled out in major urban centres including Kilkenny City resulting in an investment of €450m in broadband services.

Following the presentation, Members expressed their appreciation on the update and raised concerns/queries in relation to:

- Provision of broadband in rural areas.
- Reinstatement of footpaths/roads following the laying of new ducting, if required.
- Look at small market towns such as Thomastown.
- Future phases of project.

measures (suggestions provided by residents) be taken in conjunction with existing parking spaces to help prevent indiscriminate parking and that relevant signage be provided."

Mr. Seamus Kavanagh advised that the Council are currently reviewing the Bye Laws and this area will be included in the revised Bye Laws and it is proposed to bring the revised Bye Laws before the Members at the December meeting for consideration.
